The undersigned understands that the undersigned is responsible for the proper maintenance of the Junk Yard or Salvage Yard, and its upkeep during the License period.

The undersigned agrees to supplement this License Application with such other information as the Board may require.

The undersigned hereby submits this Application and certifies to the truthfulness of the contents hereof, knowing that the Board is relying on the same.

The undersigned shall agree that if granted the License applied for herein, that the undersigned will conduct the activity or business pursuant to the regulations set forth and that if the undersigned shall fail to do so, that this License may be revoked forthwith.

- A. Attached hereto is a map, as required by Section 99.5 of the TOWN OF WALWORTH MUNICIPAL CODE.
- B. Attached hereto is a Bond, which is submitted pursuant to the requirements of the License.
- C. The undersigned understands that any application for renewal of the License must be filed at least sixty (60) days prior to the date the License is to expire.
- D. This License must be exhibited on demand whenever requested by a police officer or officials of the Town.
- E. This License shall not be used by any person other than the licensee named herein. Any person who permits the use of the License by someone other than the licensee shall be guilty of a violation of Chapter 99 of the TOWN OF WALWORTH MUNICIPAL CODE. The undersigned agrees that he has read the regulations set forth in Chapter 99 and is familiar with the TOWN OF WALWORTH MUNICIPAL CODE and the applicable laws and rules, regulations and ordinances governing the property and the operation of the business.
