- There have been occurrences of signs being removed from residents’ yards throughout the Town. Supervisor Jacobs encouraged those who encounter this problem to contact the Wayne County Sheriff’s Office.
- The 2020 Census is almost complete. Supervisor Jacobs encouraged those who have not yet participated to go online and do so by September 28, 2020.
