

WHEREAS, a public hearing was duly advertised, and held on September 15, 2022 on the proposed Local Law No. 4 of 2022 to Update, Revise and Recodify the Walworth Town Code; and

WHEREAS, the Walworth Town Board has referred the Local Law to the County of Wayne Planning Board and has reviewed and considered any comments received in response thereto; and

WHEREAS, the Walworth Town Board has duly considered this action in accordance with the State Environmental Quality Review Act ("SEQR"); now, therefore, be it

RESOLVED, that, in accordance with SEQR, the Town Board has completed its review of parts 1 and 2 of EAF related to this action and hereby approves the parts 1 and 2 of the EAF; and be it further

RESOLVED, that in accordance with Parts 1 and 2 of the subject EAF, the Town of Walworth hereby finds that adoption of this Local Law to recodify the Code of the Town of Walworth will have no significant adverse environmental impacts; and be it further

RESOLUTION -22: SEQRA RESOLUTION - NEGATIVE DECLARATION - LOCAL LAW
NO. 5 OF 2022 TO AMEND THE OFFICIAL ZONING MAP OF THE TOWN OF
WALWORTH TO REZONE APPROXIMATELY 42+/- ACRES OF LAND AT 4320
CANANDAIGUA ROAD (TAX MAP PARCEL # 62115-00-376223), COMMONLY KNOWN
AS THE FREEWILL ELEMENTARY SCHOOL PARCEL, FROM "RR-1" DISTRICT TO
"B" DISTRICT

offered the Resolution and moved its adoption. Seconded by Council

to wit:

WHEREAS, the Town of Walworth Town Board (the "Town Board") received an application (the "Application") from K-2 Brewing, Inc. (the "Applicant") to rezone the former Freewill Elementary School, located at 4320 Canandaigua Road, Walworth, NY, 14568 from Single Family Residential (RR-1) to General Business (B). Further applications were submitted to permit the Applicant to redevelop the former school into a craft brewery/restaurant/event center (the "Project"); and

WHEREAS, in accordance with the Application, the Walworth Town Board is thus considering a proposed local law "to Amend the Official Zoning Map of the Town of Walworth to Rezone Approximately 42 +/- Acres of Land at 4320 Canandaigua Road (Tax Map Parcel # 62115-00-376223), Commonly Known as the Freewill Elementary School Parcel, from RR-1 District to B District;" and

WHEREAS, the Town Board announced its intent to serve as Lead Agency to conduct an environmental review of the project in accordance with the New York State Environmental Quality Review Act (SEQRA) and no objections were issued, therefore, the Walworth Town Board has assumed Lead Agency; and

WHEREAS, the Project is classified as an Unlisted Action under SEORA; and

WHEREAS, the Town Board accepted Applicant's Part 1 Full Environmental Assessment Form ("EAF") and circulated it to the SEQRA involved and interested agencies; and

WHEREAS, LaBella Associates prepared Parts 2 and Part 3 of the EAF on behalf of the Board, with an accompanying narrative, which the Town Board has reviewed; and

WHEREAS, in accordance with SEQRA and its regulations, the Town Board has performed its environmental review of the Applicant's project.

NOW THEREFORE BE IT RESOLVED,

- 1. The Town Board declares that it will serve as Lead Agency for Applicant's project.
- 2. The Town Board has considered the Project and its potential for environmental impacts; the Rezoning Application, Part 1 of the EAF and Parts 2 and 3 of the EAF prepared by LaBella; the criteria contained in 6 N.Y.C.R.R. §617.7(c); and other supporting information to identify the relevant areas of environmental concern; and thoroughly analyzed the identified relevant areas of environmental concern to determine if the Project may have a significant adverse impact on the

environment, and finds that the Project would not have a significant impact on the environment because of the reasons discussed in the narrative to the EAF Part 3, which is incorporated in full herein and attached hereto.

3. Pursuant to SEQRA, Parts 2 and 3 are hereby approved, and a Negative Declaration is therefore issued for this project.

RESOLUTION -22: LOCAL LAW NO. 5 OF 2022 TO AMEND THE OFFICIAL ZONING MAP OF THE TOWN OF WALWORTH TO REZONE APPROXIMATELY 42+/- ACRES OF LAND AT 4320 CANANDAIGUA ROAD (TAX MAP PARCEL # 62115-00-376223), COMMONLY KNOWN AS THE FREEWILL ELEMENTARY SCHOOL PARCEL, FROM "RR-1" DISTRICT TO "B" DISTRICT

to wit:

WHEREAS, the Walworth Town Board duly called for and held a Public Hearing on the 15th day of September, 2022, where all interested parties were heard on the proposed local law "to Amend the Official Zoning Map of the Town of Walworth to Rezone Approximately 42 +/- Acres of Land at 4320 Canandaigua Road (Tax Map Parcel # 62115-00-376223), Commonly Known as the Freewill Elementary School Parcel, from RR-1 District to B District;" and

WHEREAS, said Local Law is attached hereto and made a part hereof; and

WHEREAS, the Walworth Town Board has reviewed the potential adverse environmental impacts of the application for SEQR purposes and has issued a Negative Declaration; and

WHEREAS, the subject parcel is in an area that is appropriate for the proposed zoning for all the reasons set forth in the Local Law, including its proximity to higher traffic roads, its proximity to other properties the uses of which are not consistent with RR-1 use, and the property's historical use has been that of a public school, which is of a much greater intensity than a residential use; and

WHEREAS, the Comprehensive Plan of the Town of Walworth supports the proposed Local Law for rezoning, in that it provides that the vision of the Town is to "remain an attractive place to live and do business" and that it seeks to reward "economic development opportunities." The rezoning permits the re-use of a vacant building and avoids the need to develop other green or farmlands, consistent with the Plan's vision to protect agriculture and green spaces. Finally, the Plan calls for large scale commercial development near major roads — a goal which this rezoning would permit; and

WHEREAS, the Walworth Town Board, after review of the application, all related materials and any Town staff and public comments, and after due deliberation thereon, finds it in the best interest of the Town to adopt said Local Law such that the Town Zoning Map be amended as set forth therein; now, therefore be it

RESOLVED, that, subject to the conditions set forth herein, the Walworth Town Board hereby adopts said Local Law No. 5 of 2022 to Amend the Official Zoning Map of the Town of Walworth to Rezone Approximately 42 +/- Acres of Land at 4320 Canandaigua

Road (Tax Map Parcel # 62115-00-376223), Commonly Known as the Freewill Elementary School Parcel, from RR-1 District to B District; and be it further

RESOLVED, that this approval is conditioned upon the subsequent approval by the Planning Board of the Special Use Permits associated with the development, which approvals must be obtained no later than one year from adoption of this Resolution; and, be it further

RESOLVED, that the Walworth Town Clerk is directed to enter said Local Law into the minutes of this meeting and to give due notice of the adoption of said Local Law to the Secretary of State of the State of New York; and, be it further

RESOLVED, upon satisfaction of said condition, that the Town of Walworth Zoning Map be updated accordingly.

RESOLUTION 151-22: AUTHORIZATION TO ADOPT WAYNE COUNTY MULTI-JURISDICTIONAL HAZARD MITIGATION PLAN (TABLED)

WHEREAS, The Town of Walworth, with the assistance from Bold Planning, has gathered information and prepared the Wayne County Multi-Jurisdictional Hazard Mitigation Plan; and

WHEREAS, the Wayne County Multi-Jurisdictional Hazard Mitigation Plan has been prepared in accordance with the Disaster Mitigation Act of 2000; and

WHEREAS, The Town of Walworth is a local unit of government that has afforded the citizens an opportunity to comment and provide input in the Plan and the actions in the Plan; and

WHEREAS, The Town of Walworth has reviewed the Plan and affirms that the Plan will be updated no less than every five years;

NOW THEREFORE, BE IT RESOLVED by the Town Board that the Town of Walworth adopts the Wayne County Multi-Jurisdictional Hazard Mitigation Plan as this jurisdiction's Natural Hazard Mitigation Plan, and resolves to execute the actions in the Plan.

WHEREAS, thus, the Town Board is considering the approval of a local law which would increase the income limits relative to the senior citizen tax exemption.

NOW, THEREFORE, BE IT RESOLVED, that a public hearing be duly advertised for and held on October 20, 2022, at 6:43 p.m. for the purposes of permitting the public to speak relative to said proposed local law to increase the income limits relative to the senior citizen tax exemption; and

BE IT FURTHER, RESOLVED, that the proposed Local Law is available at the Town Clerk's Office for review by the public.





Subject: Property tax exemption for seniors and persons with disabilities and limited incomes

Gov. Kathy Hochul recently signed into law a Bill that affects property tax exemptions for seniors and persons with disabilities with limited incomes. This Bill now allows municipalities to increase the maximum income limits up to \$50,000. Currently the Town of Walworth is at \$37,399.

I would like to make the following recommendation to update the schedule of maximum income exemption eligibility levels for Section 467 of RPTL Senior citizens' exemption and Section 459-c RPTL exemption for persons with disabilities and limited income:

Annual Income Range	Exemption Percentage
\$41,000 or Less	50% exemption
\$41,001 - \$42,000	45% exemption
\$42,001 - \$43,000	40% exemption
\$43,001 - \$44,000	35% exemption
\$44,001 - \$45,000	30% exemption
\$45,001 - \$46,000	25% exemption
\$46,001 - \$47,000	20% exemption
\$47,001 - \$48,000	15% exemption
\$48,001 - \$49,000	10% exemption
\$49,001 - \$50,000	5% exemption
\$50,001 or more	Not Eligible

I am sure you are all aware of the cost of living increasing drastically over the past year or so. Many of our seniors and disabled residents are on fixed incomes and are struggling, most living on Social Security only. I highly recommend that the board pass a local law increasing the maximum income limit to \$50,000


