RESOLUTION -23: TO AUTHORIZE THE USE OF TOWN HALL CAPITAL RESERVE FUNDS TO REPLACE A HEAT PUMP IN THE TOWN HALL, SUBJECT TO PERMISSIVE REFERENDUM

WHEREAS, a heat pump serving a section of the library in the town hall has failed; and

WHEREAS, the heat pump is 30 years old and repairing it is not a viable option; and

WHEREAS, there are sufficient funds in the Town Hall Capital Reserve Fund (A231CR) to cover the estimated costs of the project;

NOW, THEREFORE IT BE RESOLVED, that the Town Board hereby authorizes the use of up to \$15,000.00 from the Town Hall Capital Reserve fund, subject to permissive referendum, to replace the heat pump and repair the ceiling as needed once the replacement is complete.
