# RESOLUTION -23: ADOPTION OF ALCOHOL AND DRUG FREE WORKPLACE POLICY

### ALCOHOL AND DRUG FREE WORKPLACE POLICY

### **Purpose**

The purpose of this policy is to secure for all Town of Walworth employees a safe, alcohol, drug-free working environment, and to ensure compliance with the Federal Drug-Free Workplace Act of 1988, PL 100-690.

The Town of Walworth is committed to protecting the safety, health and well-being of all employees and other individuals in its workplace. This policy recognizes that employee involvement with alcohol and other drugs can be very disruptive, adversely affect the quality of work and performance of employees, pose serious health risks to users and others, and have a negative impact on productivity and morale.

### **Policy**

The Town of Walworth prohibits the unlawful use, possession, sale, manufacture, distribution, dispensing, or misuses of controlled substances, use and/or possession of cannabis, alcohol, and all illegal drugs in all Town workplaces and on all Town properties, except when the use is pursuant to a doctor's orders and such order is on file with the Town.

All employees are directed not to report to work or be on duty while their ability to perform job duties is impaired due to on- or off-duty use of alcohol or other drugs.

#### Covered Individuals

Any individual who is employed by the Town of Walworth, including elected and appointed Town officials, is covered by this Alcohol and Drug Free Workplace Policy. Therefore, this policy applies during all working hours, on-call, standby, and/or while operating or riding in vehicles belonging to the Town or while operating their own personal vehicle conducting Town business. To the extent that the terms of this policy are subject to federal, state, or local laws, or terms of any collective bargaining agreement, regarding drug or alcohol testing, those respective laws or terms shall supersede any inconsistent terms of this policy.

All Town of Walworth new employees will be subject to a pre-employment drug and alcohol testing. For the purpose of this requirement, employees will be considered those individuals who receive Town benefits and are permanent part-time or full-time employees.

Employees with commercial driver's licenses shall be subject to random, post-accident and "reasonable cause" drug/alcohol testing procedures in compliance with US DOT Regulation 49 CFR Part 40 and the collective bargaining agreement.

### Consequences

One of the goals of this Alcohol and Drug Free Workplace Policy is to encourage employees to voluntarily seek help with alcohol and/or drug problems. If, however, an individual violates this policy, the consequences will be serious.

In the case of an applicant for employment who violates the Alcohol and Drug Free Workplace Policy, any conditional offer of employment can be withdrawn, where permitted by law.

Employees violating these policies shall be subject to criminal, civil, and disciplinary penalties as provided by existing statues, Civil Service rules, and relevant collective bargaining agreement provisions.

**NOW THEREFORE BE IT RESOLVED** that the Town Board of the Town of Walworth hereby adopts the proposed Alcohol and Drug Free Workplace policy, to be added to the current Employee Handbook and to be distributed to the Town of Walworth employees.

On behalf of the Wayne County Industrial Development Agency (the "Agency"), please find enclosed a completed and signed NYS Form RP-412-a, "Application for Real Property Tax Exemption" (the "Application"), along with a copy of the related signed Payment-In-Lieu-of-Tax Agreement, dated as of May 12, 2023 (the "PILOT Agreement"), and entered into by the Agency and 4320 Canandaigua Rd LLC (the "Company").

Pursuant to the Application, we ask that the Assessor please place the relevant portion of the subject tax parcel on tax roll section 8 (exempt) as of March 1, 2024 Taxable Status Date, with future in-lieu-of-tax payments administered in accordance with Schedule A of the PILOT Agreement. To the extent you will establish a new or stub parcel number for this Project, we ask that you please assign both a land value and improvements value to assist the Agency and affected tax jurisdictions with administering billing for this PILOT Agreement. To assist you with establishing a new or stub parcel for the Project, we have also enclosed the Project survey and legal description for you to reference.

For the term of this PILOT Agreement, the Company shall pay full taxes based on the assessed value of the Land before the completion of any Project improvements (the "Base Valuation"). During the term of this PILOT Agreement, the Base Valuation shall be frozen at \$2,428,200 Full Market Value (as equalized), or such assessment assigned to the land by the applicable assessor as of March 1, 2024. The Total Taxable Valuation for each Total PILOT Payment shall be calculated such that a graduated abatement factor ("Abatement Factor") shall be applied to the increased assessed valuation attributable to the Improvements made to the Project Facility by the Company, as an Agent of the Agency, for the Project (the "Added Value"). The abatement schedule shall allow for a 100% exemption from taxation for the Added Value in the first five PILOT Years, with such exemption being reduced to 50% for PILOT Years 6-10.

Once the Total Taxable Valuation is established using the Abatement Factor, the Total PILOT Payment shall be determined by multiplying the Total Taxable Valuation by the respective tax rate for each affected tax jurisdiction (after application of any applicable equalization rate). After the tenth PILOT Year, the Project Facility shall be subject to full taxation by the affected taxing jurisdictions.

Total Taxable Valuation = Base Valuation + (Added Value x Abatement Factor)
Total PILOT Payment = Total Taxable Valuation (after equalization) x Tax Rate

\* - for purposes of the Total PILOT Payment payable as of September 30, 2023, the Payment shall include a pro-rated number of days for each of the 2023 Town/County Tax Year and 2022/2023 School Tax Year within which the Company owned the Land and Existing Improvements (utilizing the applicable tax rates of each affected tax jurisdiction for those tax years), plus the full amount of Total PILOT Payment for the 2024 Town/County Tax Year and 2023/2024 School Tax Year

RESOLUTION URGING THE NEW YORK STATE LEGISLATURE AND GOVERNOR KATHY HOCHUL TO DRAFT AND ENACT LEGISLATION REGARDING A VOTER'S IDENTIFICATION PROCESS

Resolution for Town Board Meeting Dated: May 9, 2023

The following resolution was offered by: COUNCILMAN COOK

and seconded by: COUNCILMAN BENNARDO

WHEREAS, this country was formed on the principles of democracy and our forefathers fought for our right to elect our representation; and

WHEREAS, the majority of the states in the U.S. require a voter's identification to increase the public's confidence and ensure a fair election process; and

WHEREAS, the Board of Elections may not get notification of a voter registering in another location or of a death of a registered voter; and

WHEREAS, in an economy where the Board of Elections may not have sufficient funding or staffing to purge voters rolls of individuals who no longer live in each election district or county, as required; and

WHEREAS, in a day and age where the ability to work does not necessarily need to be where you live, this allows for more individuals to be transient in nature and the addition of voter's identification will assist in keeping all voter rolls current; and

WHEREAS, in the State of New York the requirement is to compare the signature on file, this doesn't necessarily help maintain current voter registration, as name and address changes are not necessarily communicated in the current process, also this would assist in the purging of the roles of individuals who are no longer active voters in that county; and

WHEREAS, the subject of the resolution is not an action as defined by 6 N.Y.C.R.R. §617.2 (b), and therefore no further SEQRA review is required.

NOW, THEREFORE,

THE TOWN BOARD

HEREBY REQUESTS the New York State Legislature and Governor Hochul to draft and enact legislation to allow for a voter's identification process to assist with maintaining voter's registration rolls; and

BE IT RESOLVED, that the Town Clerk is hereby directed to forward certified copies of this resolution to Governor Hochul, Andrea Stewart-Cousins, President Pro Tempore and Majority Leader, Carl E. Heastie, Speaker of the Assembly and the Huntington Delegation to the New York State Legislature: Assemblyman Steve Stern, Assemblyman Keith Brown, and Senator Mario Mattera.
